I am writing to provide you with information about the FREE strategic business advice service, funded by Defra Future Farming Resilience Fund, (FFRF) that we at DJM Consulting are offering to farmers/land managers.

### Free Strategic Business Advice

DJM Consulting (DJMC) are delivering up to 2 days of free business advice, per farmer, in the form of 1 to 1 strategic on farm meetings, funded by Defra Future Farming Resilience Fund, (FFRF).

FFRF is designed to provide free business support to farmers and land managers during the ongoing period of change to direct payments, including:

- understand the changes that are happening i.e. removal of BPS
- identify how, what and when they may need to adapt their business
- access tailored support/advice to adapt

#### What can DJMC do for you under FFRF?

This service is what DJMC do on a day-to-day basis and normally charge for – under this scheme farmers and land managers get it for free and we <u>tailor the advice to meet their need</u>. Examples of advice that we provide to farmers include:

#### What is the catch?/Why are Defra funding it? Who is eligible?

There is no catch! In England there has been support for farmers since the 1947 Agricultural Act – this ended on 31st December 2023 with Defra removing agricultural support (BPS). Defra want to, and be seen to, provide support to farmers during this dramatic period of change. The eligibility requirements are; the farmer/land manager must be in England and in receipt of delinked payments (BPS) or be a Higher Level Stewardship claimant, with a Single Business Identifier (SBI) number.

#### What should you do?
